<b>Title/Subject:</b> Anti-Social Behaviour (ASB) Immediate Justice pilot funding allocations 2023/24
<b>Serial No:</b> MPCC294
<b>Summary:</b> To seek agreement to allocate up to £1m for the proposed services to deliver the West Yorkshire ASB Immediate Justice Pilot funded by the Department for Housing, Levelling Up and Communities (DHLUC). Proposed services: <b>Adults</b> <ul style="list-style-type: none"><li>• Supervised unpaid work activity of up to 20 hours in communities impacted by ASB for those who are referred or receive and out of court disposal for ASB behaviour.</li><li>• Restorative justice and ASB awareness courses</li></ul> <b>Children (aged 12 to 17 years)</b> <ul style="list-style-type: none"><li>• Restorative Justice workers across West Yorkshire supporting reparative activities and opportunities for children who frequently have records for ASB behaviours.</li><li>• Deliver positive activities including health and wellbeing, educational, involvement in community groups and activities that will develop a child sense of victim empathy and the need to repair harm.</li><li>• Diverting them away from and preventing further ASB or offending that impacts their communities.</li></ul> <b>Victims and Communities</b> <ul style="list-style-type: none"><li>• Engagement and consultation with victims of ASB.</li><li>• Restorative Justice victim engagement.</li><li>• Support and engagement for victims of ASB.</li><li>• Develop and facilitate community conferences with groups of victims and offenders.</li></ul>
<b>Requested Decision:</b> To agree the allocations of up to £1m to the proposed services to deliver the West Yorkshire ASB Immediate Justice Pilot funded by the Department for Housing, Levelling Up and Communities (DHLUC).
